Nifty weekly contract has highest open interest at 20000 for Calls and 19900 for Puts while monthly contracts have highest open interest at 20000 for Calls and 19000 for Puts. Highest new Ol addition was seen at 20000 for Calls and 19900 for Puts in weekly and at 20000 for Calls and 19900 for Puts in monthly contracts. FlIs decreased their future index long position holdings by 24.14%, decreased future index shorts by 7.96% and decrease in index options by 20.43% in Call longs, 10.26% in Call short, 8.97% in Put longs and 1.13% in Put shorts.
