Comments:

Nifty weekly contract has highest open interest at 25200 for Calls and 25000 for Puts while monthly contracts have highest open interest at 27000 for Calls and 25000 for Puts. Highest new OI addition was seen at 25200 for Calls and 23050 for Puts in weekly and at 26000 for Calls and 25300 for Puts in monthly contracts. FIIs decreased their future index long position holdings by 2.54%, increased future index shorts by 0.85% and in index options, 6.82% increase in Call longs, 0.99% decrease in Call short, 10.64% increase in Put longs and 4.30% decrease in Put shorts.
