Comments:

Nifty weekly contract has highest open interest at 21000 for Calls and 20000 for Puts while monthly contracts have highest open interest at 21000 for Calls and 19000 for Puts. Highest new OI addition was seen at 21000 for Calls and 19000 for Puts in weekly and at 20200 for Calls and 19000 for Puts in monthly contracts. FIIs decreased their future index long position holdings by 9.60%, decreased future index shorts by 34.14% and decreased in index options by 57.16% in Call longs, 52.33% decrease in Call short, 62.05% decrease in Put longs and 64.41% decease in Put shorts.
