Comments:

Nifty weekly contract has highest open interest at 21000 for Calls and 20900 for Puts while monthly contracts have highest open interest at 21000 for Calls and 19000 for Puts. Highest new OI addition was seen at 21500 for Calls and 20400 for Puts in weekly and at 21500 for Calls and 20400 for Puts in monthly contracts. FIIs increased their future index long position holdings by 0.76%, increased future index shorts by 3.84% and in index options by 12.57% in Call longs, 0.27% in Call short, 28.13% in Put longs and 3.53% in Put shorts.
