Comments:

Nifty weekly contract has highest open interest at 21000 for Calls and 20900 for Puts while monthly contracts have highest open interest at 21000 for Calls and 19000 for Puts. Highest new OI addition was seen at 21000 for Calls and 20500 for Puts in weekly and at 21000 for Calls and 20500 for Puts in monthly contracts. FIIs increased their future index long position holdings by 10.74%, decreased future index shorts by 1.99% and in index options by 17.87% increase in Call longs, 7.02% decrease in Call short, 18.84% increase in Put longs and 10.10% decrease in Put shorts.
