Nifty weekly contract has highest open interest at 20000 for Calls and 19900 for Puts while monthly contracts have highest open interest at 20000 for Calls and 19000 for Puts. Highest new OI addition was seen at 20100 for Calls and 19900 for Puts in weekly and at 20500 for Calls and 19900 for Puts in monthly contracts. FIIs increased their future index long position holdings by 8.94%, decreased future index shorts by 0.34% and increased index options by 26.67% in Call longs, 14.85% in Call short, 32.77% in Put longs and 22.21% in Put shorts.
