Nifty weekly contract has highest open interest at 25000 for Calls and 25000 for Puts while monthly contracts have highest open interest at 25000 for Calls and 25000 for Puts. Highest new OI addition was seen at 25300 for Calls and 24400 for Puts in weekly and at 25300 for Calls and 24400 for Puts in monthly contracts. FIIs increased their future index long position holdings by 5.60%, decreased future index shorts by 4.64% and in index options by 3.03% decrease in Call longs, 2.10% decrease in Call short, 2.46% decrease in Put longs and 1.19% decrease in Put shorts.
